

RESOLUTION NO. 2002-2598

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF VILLA PARK APPROVING THE NINTH AMENDMENT TO THE EXCLUSIVE FRANCHISE AGREEMENT WITH TAORMINA INDUSTRIES, INC. FOR THE COLLECTION, TRANSPORTATION, REMOVAL AND/OR DISPOSAL OF ALL SOLID WASTE GENERATED WITHIN THE CITY OF VILLA PARK, CALIFORNIA

WHEREAS, the City Council and Contractor have determined that the Consumer Price Index supports the need for a rate increase; and

WHEREAS, the City and Contractor desire to amend the existing Agreement by entering into a Ninth Amendment.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF VILLA PARK DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. The Ninth Amendment to the Exclusive Franchise Agreement, including the new rate schedule attached hereto as Exhibit "A" and by this reference incorporated herein, is approved.

Section 2. In all other respects the Exclusive Franchise Agreement, as amended, shall remain in full force and effect.

EXCLUSIVE FRANCHISE AGREEMENT RATES**

Effective July 1, 2002, the following Schedule of rates and charges for solid waste services shall apply:

RESIDENTIAL ACCOUNTS

<i>Residential Service:</i>	\$15.97 per month
Residential services includes the following: One refuse container for non-recyclable and non-compostable waste One refuse container for compostable waste One refuse container for recyclable waste Collection is once per week for all containers	
<i>Each additional refuse container for non-recyclable and non-compostable waste:</i>	\$5.60 per month
<i>Each additional refuse container for compostable waste:</i>	\$2.70 per month
Additional containers for recyclable wastes shall be furnished without charge Bulky item collection up to 3 times per year shall be furnished without charge
