

ORDINANCE NO. 2003-492

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF VILLA PARK
AMENDING SECTION 19-4.1 OF CHAPTER XIX OF THE VILLA PARK
MUNICIPAL CODE DESIGNATING SPEED LIMITS

THE CITY COUNCIL OF THE CITY OF VILLA PARK HEREBY ORDAINS AS FOLLOWS:

SECTION 1: Section 19-4.1 of Chapter XIX of the Villa Park Municipal Code is hereby amended in its entirety to read as follows:

19-4.1. Designated. The Council does hereby determine and declare that the following speed limits are most appropriate to facilitate the orderly movement of traffic and is reasonable and safe and that the prima facie speed limits of the following streets shall be as hereinafter set forth:

a. 45 MPH Zone:

1. Meats Avenue from Santiago Boulevard to North City limit.
2. Cannon Street from Taft Avenue to North City limit.

b. 40 MPH Zone:

1. Villa Park Road from Wanda Road to Center Drive.
2. Villa Park Road from Center Drive to Lemon Street.
3. Wanda Road from Collins Avenue to Villa Park Road.

c. 35 MPH Zone:

1. Lemon Street from Villa Park Road to Santiago Boulevard.
2. Lemon Street from Santiago Boulevard to Taft Avenue.
3. Lemon Street from Taft Avenue to Valley Drive.
4. Santiago Boulevard from South City limit to Bishop Circle.
5. Santiago Boulevard from Wanda Road to Center Drive.
6. Santiago Boulevard from Center Drive to Lemon Street.
7. Santiago Boulevard from Lemon Street to Sycamore Street.
8. Taft Avenue from Santiago Boulevard to Center Drive.
9. Taft Avenue from Center Drive to Lemon Street.
10. Taft Avenue from Lemon Street to Sycamore Street.
11. Taft Avenue from Sycamore Street to Cannon Street.
12. Center Drive from Serrano Avenue to Valley Drive.

d. 30 MPH Zone:

1. Cerro Villa Drive from Valley Drive to Rama Street.
2. Lincoln Street from Wanda Road to Center Drive.
3. Mesa Drive from Lemon Street to Loma Street.
4. Valley Drive from Center Drive to Lemon Street.
5. Valley Drive from Lemon Street to Rama Street.
6. Valley Drive from Rama Street to Cerro Villa Drive.
7. Center Drive from Lincoln Street to Villa Park Road.
8. Center Drive from Villa Park Road to Santiago Boulevard.

- 9. Center Drive from Santiago Boulevard to Serrano Avenue.

e. 25 MPH Zone:

- 1. Mesa Drive from Crestview Circle to Canyon Drive.
- 2. Cerro Villa Drive from Rama Street to Canyon Drive.

SECTION 2: Ordinance No. 2001-479 is hereby repealed in its entirety.
