

**CITY OF VILLA PARK**  
NOTICE INVITING SEALED BIDS  
FOR  
**STREET MAINTENANCE PROJECT**  
**FY 2008-09**

NOTICE IS HEREBY GIVEN that sealed bids will be received by the **City of Villa Park**, as Agency, for furnishing all materials, equipment, tools, labor and incidentals as required for the above stated project in strict accordance with the specifications and drawings on file at the office of the City Clerk of the **City of Villa Park**

Bids will be received at the office of the City Clerk, **City of Villa Park**, until **2:00 p.m.** on the **8<sup>th</sup>** day of **October, 2008**, at which time and place the bids will be publicly opened and read aloud. Bids shall be submitted in sealed envelopes marked on the outside, "SEALED BID FOR STREET MAINTENANCE PROJECT – F.Y. 2008-09 - DO NOT OPEN WITH REGULAR MAIL".

The work to be constructed hereunder is located in the **City of Villa Park**, and as shown on the construction plans. The work generally consists of: The placement of Rubberized Aggregate Slurry and asphalt rubberized hot mix (ARHM) overlay at various streets; Removal & Replacement of A.C./A.B. Pavement and AC Patch Back. Construction of Concrete Driveway .Replacement and construction of Concrete Curb & Gutter and concrete cross gutter spandrel and Asphalt Rubberized Hot Mix Overlay Replacement; Adjustment fo Utility Frames and Cover to grade, Street Striping and Pavement Legends; and all appurtenant related work.

The Agency reserves the right, after opening bids, to reject any or all bids, or to make award to the lowest responsible bidder and reject all other bids; to waive any informality in the bidding; and to accept any bid or portion thereof; and to take all bids under advisement for a period of forty-five (45) days. Bids will be compared on the basis of the Engineer's estimate of the quantities of the several items of work as shown on the Bid Sheets. Only such plans, specifications, and items of work as are appropriate shall apply to the work as bid.

At the time of contract award, the contractor shall possess a Class A Contractor's License.

Each bid must be accompanied by a certified or cashier's check, or by a corporate surety bond on the form furnished by the AGENCY, as a guarantee that the bidder will, if an award is made to him in accordance with the terms of his bid, promptly secure workmen's compensation insurance and liability insurance, execute a contract in the required form, and furnish satisfactory bonds for the faithful performance of the contract and for the payment of claims of material and laborers thereunder. Said check or bidder's bond shall be in an amount not less than 10 percent of the amount of the bid. The Performance Bond shall be not less than 100 percent of the total amount of the bid price named in the contract. The Payment Bond shall be not less than 100 percent of the total amount of the bid price named in the contract. The AGENCY reserves the right to reject any bond if, in the opinion of the AGENCY Attorney, the Surety's acknowledgment is not in the form

included in the contract documents or in another form substantially as prescribed by law.

Complete sets of said contract documents may be purchased at a cost of \$30.00 per set and are obtainable from the City Clerk of the **City of Villa Park**, 17855 Santiago Boulevard, Villa Park, CA 92667-4187. No refund will be made of any charges for complete sets of contract documents. Plans and specifications can be mailed for an additional \$10.00 per set or call for express delivery rates.

Any Contract entered into pursuant to this notice will incorporate the provisions of the State Labor Code. Compliance with the prevailing rates of wages and apprenticeship employment standards established by the State Director of Industrial Relations will be required. Affirmative action to ensure against discrimination in employment practices on the basis of race, color, national origin, ancestry, sex or religion will also be required.

The AGENCY hereby affirmatively ensures that minority business enterprises will be afforded full opportunity to submit bids in response to this notice and will not be discriminated against on the basis of race, color, national origin, ancestry, sex or religion in any consideration leading to the award of contract.

The Contract Documents call for monthly progress payments based upon the Engineer's estimate of the percentage of work completed. The AGENCY will retain 10 percent of each progress payment as security for completion of the balance of the work. At the request and expense of the successful bidder, the City will pay the amounts so retained upon compliance with the requirements of Government Code Section 4590 and the provisions of the Contract Documents pertaining to Substitution of Securities.
